**RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, APPROVING WAIVER REQUEST FOR A ROAD OPENING PERMIT SUBMITTED BY BRUCE PAULSON, FOR BLOCK 114.32, LOT 25, A/K/A 129 SCHOONER DRIVE, BARNEGAT, NEW JERSEY**

**WHEREAS**, the Township of Barnegat, County of Ocean, State of New Jersey, (hereinafter referred to as the "Township") has received a request from Bruce Paulson (the "applicant") for a road opening permit for a single-family home at 129 Schooner Drive, Barnegat, New Jersey, a/k/ a Block 114.32, Lot 25 (the "property"); and
