

RESOLUTION NO. 2010 - 323

RESOLUTION OF THE TOWNSHIP OF BARNEGAT, COUNTY OF OCEAN, STATE OF NEW JERSEY, AUTHORIZING EXTENSION OF INTERLOCAL SHARED SERVICES AGREEMENT WITH THE TOWNSHIP OF OCEAN FOR THE PURPOSE OF SHARING TOWNSHIP ADMINISTRATOR SERVICES

WHEREAS, the Township of Barnegat, County of Ocean, State of New Jersey (hereinafter referred to as the "Township"), has previously entered into a Shared Services Agreement with the Township of Ocean, County of Ocean, State of New Jersey ("Ocean Township") with regard to the sharing of Township Administrator services; and

WHEREAS, the prior Agreement dated March 25, 2010 expired on its own terms and conditions on June 30, 2010; and

WHEREAS, the Township and Ocean Township have jointly benefitted from the Shared Services Agreement, and both the Township and Ocean Township wish to extend the Interlocal Shared Services Agreement dated March 25, 2010 to December 31, 2010:

NOW, THEREFORE, BE IT RESOLVED, this 19th day of July, 2010, by the Township Committee of the Township of Barnegat, County of Ocean, State of New Jersey, as follows:

1. The Township hereby authorizes an extension of the Interlocal Shared Services Agreement with the Township of Ocean for the purpose of sharing Township Administrator services to December 31, 2010.
